- 4. The offers submitted and the price quoted shall be valid for 60 days, from the date of opening of quotation.
- 5. The prices finalized are fixed during the validity of contract period.
- The item shall be delivered on door delivery basis at Muvattupuzha Milk Chilling Plant within 20 days of firm order.
- 7. The EMD shall be in the form of:
 - By Demand Draft (valid for a period of 3 months) from a Nationalized/scheduled Bank drawn in favour of The Managing Director, ERCMPU, payable at Edappally, Kochi.
 - b. Payment in cash at Head Office, Edappally on all working days.
 - Any quotation without EMD shall be treated as non-responsive & shall be liable for rejection.
