3. Successful bidder shall execute an agreement in a stamp paper worth Rs. 200/- in the prescribed format covering the warranty period.
4. The filled and super scribed quotation should be received in this office on or before 10.10.2017 at 2.00 PM and the same will be opened at 2.30 PM.

5. The bidder should have supplied at least 50 nos of Rubber mat at any of the Milk Cooperative Units under KCMMP or any other Milk Unions in India. Proof of the same may be submitted along with the quotation, failure of which will lead to disqualification of the tenderer. (Copy of Purchase Orders, Copy of Invoice or Letter from Customers)
6. The offers submitted and the price quoted shall be valid for 60 days, from the date of opening of quotation.
7. The prices finalized are fixed during the validity of contract period.
8. The item shall be delivered on door delivery basis at Kuttampuzha APCOS within 20 days of firm order.
9. The **EMD Rs. 2000/-** shall be in the form of:
  - a. By Demand Draft (valid for a period of 3 months) from a Nationalized/scheduled Bank drawn in favour of The Managing Director, ERCMPU, payable at Edappally, Kochi.
  - b. No other form of EMD remittance shall be accepted.
  - c. Any quotation without EMD shall be treated as non-responsive & shall be liable for rejection.
  - d. Un-successful tenderer's EMD shall be discharged / refunded as promptly as possible as but not later than 60 days after expiry of tender validity. The EMD shall not carry any interest.
  - e. The EMD of successful tenderer shall be discharged only after the supply of item.
10. The rate quoted should be inclusive of all taxes and duties, Packing, Freight, and Insurance etc.
11. 100% payment will be made within 20 days against the safe receipt of goods at site.
12. Statutory deduction if any applicable will be deducted from your bill as per norms.
